

**JHS Swimming and Diving Booster Club**  
**Meeting Minutes**  
**October 8, 2019 | 7:00 p.m. | JHS Room A101**

Meeting was called to order at 7:01 p.m. by Karen Zimmermann. Motion to approve the September Minutes was made by Matt Thayer and seconded by Christine Ferrante. Motion approved.

**Coach's Report:**

- Still finalizing coaches.

**President's Report:**

- **Media Guide** - Dave Zablo to provide the media guide form to the Booster Club for distribution. Karen to include a copy with her Welcome Letter. The Booster Club is looking to sell additional ads to businesses in the community. Karen Zimmermann and Robyn Ricciuti-Culp to handle.
- **Viking Invitational** - chaired by Christine Snyder. Staci Thayer has reserved the room and requested a check for payment. A question was asked whether the B Flight was also paid for by the Booster Club, Chris Snyder confirmed that is it.

- **Restaurant Fundraisers** - Chris Snyder volunteered to handle. Has forms from Chipotle, will pick date in near future.
- **Senior Banners** - Chris Snyder will handle this with Dave Zablo. Pina stated that Rob Weinland will still take Senior pictures (and team action photos!).
- **Warm-Ups** - Heidi Crawn is handling, will be distributed on November 6. Warm-ups are to be worn to school for picture day on November 7.
