

**JHS Swimming and Diving Booster Club

Coach's Report (provided by Chris Snyder):

- Our season is off to a great start! Both teams are currently 4-0 and looking strong heading into our winter training. Many thanks to all of our parent volunteers that have worked at the team feeds and the meets to help things run smoothly!
